## Adoption Contract

The following rules for adoption must be agreed to, and accepted by all adoptive parties:

1. The Adopter agrees to pay a standard adoption fee to **LABRADOR RETRIEVER RESCUE ONTARIO**, (LRRO) to cover such costs as spaying/neutering, medical examinations, and basic immunizations. The adoption fee is non-refundable.
2. The Adopter shall take the Animal to a veterinarian of their choice, within one week of the date of the contract for a medical check, and veterinarian consultation. LRRO makes no representation or warranties as to the health of the Animal.
3. The Adopter shall provide the Animal with necessary veterinary care in the event of sickness, disease or injury. In addition, the Adopter shall take the Animal to a licensed veterinarian once a year for an annual health examination and routine vaccinations.
4. The Adopter shall provide the Animal with humane care and maintain it in accordance with all current and future provincial and municipal laws and ordinances where the Adopter resides.
5. If, for any reason, the Animal cannot be kept by the Adopter, the Adopter shall contact LRRO prior to taking any action. LRRO reserves the right to re-accept the Animal back into the program. The Adopter agrees that the Animal will not be sold, traded, given away or disposed of in any way without the knowledge, and permission of the LRRO. The Adopter further agrees that the Animal will not be used for vivisection, or any experimental purposes whatsoever.
6. The Adopter, from the date of this contract, agrees to release and indemnify LRRO from any and all claims, known and unknown, now or hereafter arising in connection with the Animal.
7. The Adopter shall provide the Animal with a fully fenced yard or other humane means of exercise. The Animal shall not be kept chained outside or inside for any reason. The Animal shall be kept inside the home when nobody is at home, and shall sleep inside the home at night.
8. The Animal shall reside at the Adopter's address.
9. The Animal shall only be used as a household pet. Aggression training of any nature is prohibited.
10. The Adopter shall provide a collar and identification tag for the Animal to wear at all times. Electric collars will not be used.

11. The Animal shall be subjected only to such restraints, training devices and methods as approved by LRRO.
12. The Adopter consents to examination of the Animal by LRRO at any time. The Adopter also consents to reclamation of the Animal by LRRO at any time for failure to comply with the terms and conditions of this contract or for any misrepresentation of fact made by the Adopter on LRRO Request for Adoption form by reference.
13. The Adopter agrees to pay LRRO any and all expenses, including court costs and reasonable attorney fees, in enforcing the terms and provisions of this contract.
